(3) Give proper credit for the audio/video(s). Unless otherwise stated the credit line should read:

Archives, should also be included in the credit. The placement of credit should be as follows:

(A) Printed material - The credit line should appear on the same page as a printed copy of a video image and immediately next to it. If done so that readers can quickly match a credit with its respective video image the credit may appear somewhere else in the publication.

(B) Films, video clips, or electronic/digital media - The credit line should appear on the film, video clips, or electronic/digital media where other sources are listed. If booklets, pamphlets, etc. accompany films or video clips, the credit should appear where the subject of the copyrighted material is discussed in the text.

(C) Public screenings, exhibitions - The credit line should appear within the screening, exhibit area.

(4) Assume all responsibility for questions of copyright and invasion of privacy that may arise in the copying and in the use of the audio/video(s), and to assume responsibility for obtaining all necessary permissions pertaining to use.

(5) Defend and indemnify and save and hold harmless The Ninety-Nines, Inc., its 99s Museum of

Women Pilots Archives/Database, its employees and designates, and the donors and former owners of 99s Museum of Women Pilots Archives/Database collections, from any and all costs, expense, damage and liability arising because of any claim whatsoever which may be presented by anyone for loss or damage or other relief occasioned or caused by the release of audio/video(s), to the undersigned applicant and their use in any manner, including inspection, publication, reproduction, duplication, film production, or printing by anyone for any purpose whatsoever.

(6) Provide The Ninety-Nines, Inc, one complimentary copy of any recorded, printed or published work in which one or more video images appear or there is a use of an audio/video recording.

(7) Do not to permit others to reproduce the audio/video(s).

(8) Destroy any digitized copies of the audio/video(s) following their use.

(9) Do not place the audio/video(s) on to the Internet (unless granted permission to do so).

(10) The Ninety-Nines, Inc. shall reserve the right to review and approve any edits to the requested audio(s)/video(s) and may deny usage.

(11) The Ninety-Nines, Inc. in no way surrenders its own right to publish or otherwise use audio/video(s), or to grant permission for others to do so. That The Ninety-Nines, Inc. reserves the right to make exceptions or additions to the conditions stated herein.
